## **Message from Ottawa**

Compiling these Annual Reports has become something that we look forward to as it gives us an opportunity to not only look back and review the year, but also helps to point us to the future.

2017 was eventful on many fronts. The Canadian industry faced uncertainty over the looming Softwood Lumber Trade deal with the U.S., and as we have reported, the U.S Coalition leading the charge for penalties on Canadian softwood lumber threw a curveball and sought to include items which were previously exempt under former trade arrangements. Assembled pallets and "pallet kits" were now on the table. The CWPCA, along with a host of other partners, worked to-



gether to petition the Canadian Government to hear our voices and work with us to exclude these items. Our members rallied and formed the Trade Advisory committee in late 2016 and worked diligently through 2017 to guide our efforts. In the end we pulled out a small victory by ensuring that assembled pallets were not subject to duties, however we lost the battle when it came to cut stock in the form of pallet kits. As this is written, things are pretty quiet on this front, with other issues taking center stage.

July of 2017 marked the beginning of very strong upwards pressure on lumber pricing that continues to this day. While some of this has been influenced by the implementation of duties, there are many other factors at play. Current indicators do not point to an end to the rising prices any time soon, however, our industry is home to many resilient and resourceful individuals who are finding a way to make it all work!

Life in and around the CWPCA office has been busy as well. 2017 was the first year that the CWPCA had full control over the HT Program from a business perspective, having completed a transaction to bring the services of the inspection team in house. The transition has been seamless and we look forward to continuing with the team. Speaking of the HT program, the CFIA announced late in 2016 that they would be stepping up their role as the oversight agency while delegating operational tasks and autonomy to the service providers in what is known as their Alternate Service Delivery model. 2017 was a preparation year for us as we readied ourselves and our clients for the large-scale audit being conducted by CFIA in late 2018 and early 2019.

We sincerely hope that you will take some time and read through this report and would encourage you to provide feedback. We want to hear from you and are always open to your suggestions and recommendations as to how we can continue to provide the best services to our members.

# Highlights from 2017

#### **Advocacy and Policy**



#### 1 In person meeting

CWPCA has been maintaining a presence with our US counterparts at their respective AGM's which continues to support the growing ties between the three organizations. Scott attended the WPA Annual Meeting in California



**3 submissions** to Global Affairs Canada on SLA, arguing that assembled pallets, unassembled pallets, and notched stringers should be excluded from the scope.



Brian attended the NWPCA Annual Leadership Conference in March, where he and two CWPCA members were at the table for the first time at the Global Pallet Forum. We now also hold a seat within the Pallet Foundation, represented by one of our members.



CWPCA received **national television exposure** for efforts aimed at minimizing the impact of softwood lumber duties on wood packaging. Sukhi Brar (Advance LumberRemanufacturing), CWPCA Vice President, appeared on CBC while Brian Isard appeared on CTV.

These things are very significant as it recognizes our place in not only the North American industry, but globally. CWPCA provides a platform for a collective voice for our members, strength in numbers if you will. The Global Pallet Forum and Pallet Foundation further provide a vehicle for our voices to unite with those around the globe and deal with common issues



#### **HT Program**



We officially took over from our subcontractor Douglas Taylor & Associates on January 1, 2017, **bringing the inspection service in-house** 



We had **13 inspectors**, covering all of Canada with the exception of PEI and the territories



**Signed** new contract with CFIA for **three more years** 



Our **annual inspectors meeting** was held in Toronto in January 2017



We recruited **3 new members** for the CWPCA Packaging Committee



Scott travelled to conduct **surveil-lance audits** with inspectors in NB, NS, ON, MB, SK, QC, for training and quality assurance.



We ended the year with a total of 458 Registered facilities



Our 2017 Client Satisfaction Survey found **92%** Satisfaction with our customer service and **94%** Satisfaction with our inspectors



We completed a total of **1532**Inspections



A new CFIA Q&A document was released in February , which included clarity on requirements for unassembled packaging as well as new rules for dunnage



CWPCA issued 9 Major nonconformances and 48 minor nonconformances



A **new emphasis** was placed on **traceability** (e.g. cut stock) and kilns in 2017, part of our continual effort to improve ISPM 15 compliance.



We released a **case study** and suggested procedure on **live pest interception** as part of our annual HT Program Update.



#### Membership



CWPCA launched a **new website** in October 2017, combining canadianpallets.com and woodpackaging.ca into the one stop for information on the HT Program and Association



We launched a **Production & Recycling Survey** to gather data on lumber purchases and productivity in the industry for lobbying and advocacy purposes. We were also hoping to use the data in our joint pursuit of an Environmental Product Declaration through Natures' Packaging



Canadianpallets.com had a total of **15,397 visits** in 2017, including **767 searches for suppliers** 



We are extremely happy to report that 2017 saw a 100%

renewal of members and as with the previous 2 years, we have been able to sustain a growth rate of approximately 5%



Our **AGM** was held in Lac Leamy, QC, in the National Capital Region, where delegates were treated to a first-class facility, an exceptional evening of fun and networking. The program featured presentations covering international trends, Nature's Packaging, the softwood situation, and a thought provoking presentation looking at the move towards the circular economy



6 new members joined the Association in 2017, bringing our total to 112 manufacturing members, 47 associate members and 2 affiliate members



CWPCA's **Board of Directors** reduced from seventeen to fifteen directors to reduce costs. There were elections at AGM due to increased interest in participating. Ten members ran for seven seats (only half the board runs in any given year)



2017 also saw the seeds planted for the co-hosting of INTERPAL with the NWPCA. Although the event will take place in September of 2018, much of the initial planning and groundwork for this event was laid long before the calendar turned to the new year



#### **Nature's Packaging**



As a part of the collaborative efforts with the NWPCA and WPA, work began on the wood pallet "Environmental Product Declaration" that will soon become part of your arsenal of tools geared towards communicating the full sustainability message that our industry possesses



There were **95 Downloads** of the Nature's Packaging logo in 2017



**3,444 total visits** to naturespackaging.org, made by **3,408 unique visitors** 



**Research** on most key points was completed, including a study done in conjunction with Virginia Tech on landfill avoidance



There was a **renewed focus on marketing**, reaching a wider audience with the environmental benefits of wood packaging

#### **Regulatory Affairs**



**2 submissions** were made to Technical Committee for policy reviews on mark obliteration and removing the need for the Committee to approve the work of Third Party Kiln Auditors.



We held a webinar on WSIB rate modernization given by Mackenzie Pineda, Assistant Director on the Rate Framework Modernization






# **CWPCA Production & Recycling Survey**




ISPM-15 certified






#### Where does the data come from?
